COMPETENCIES FOR A PERIOPERATIVE NURSE SPECIALIST

1. Nature of specialization

A Perioperative Nurse Specialist is a Professional Nurse and Midwife who has obtained a *postgraduate diploma* in the perioperative field.

2. Context

The Perioperative Nurse Specialist provides care during *pre-, intra-* and *post-operative* periods.

The *pre-operative period* is the phase before surgical intervention and can occur in community clinics/community health centres and hospital wards/units or outpatients' sections. It could either be a planned or an emergency surgical intervention.

The *intra-operative period* takes place in the operating theatre, and the *post-operative period* is the period following surgical intervention, which can be either in the recovery room or in a high care/intensive care unit (ICU), depending on the acuity of the patient's condition.

3. Continuum

The Perioperative Nurse Specialist provides care in the community clinics/community health centres and hospital wards/units or outpatients' sections, in operating theatres and recovery rooms or high care/intensive care units, depending on the acuity of the patient's condition.

4. Competency overlaps

The competencies of a Perioperative Nurse Specialist overlaps with that of a Critical Care Nurse Specialist and Advanced Midwife Specialist.
