- 1.1 This is a contract for the appointment of a consultant to conduct nursing practice / task analysis for licensure examination over an eighteen (18) months period.
- 1.2 SANC reserves the right to extend or cancel the contract, pending available funding and satisfaction with service delivery.

2. ACCEPTABLE BIDS/OFFERS:

- **2.1** The SANC reserves the right to cancel or withdraw the bid without prior notification.
- 2.2 SANC is not obliged to award the quotation to the lowest bidder.
- 2.3 The SANC may request interviews/presentations/pitching sessions with shortlisted bidders before the final selection is made.
- 2.4 The SANC will not be liable for any cost incurred by a service provider in the process of responding to this bid, including on-site presentations and the preparation of the proposal.
- 2.5 The SANC will not consider any late bids. All bids submitted after the stipulated closing date and time will not be considered and it will be sent back to the bidder unopened.
- 2.6 Any effort by the bidder to influence bid evaluation, bid comparisons or bid award decisions in any manner, may result in rejection of the bid concerned.
- 2.7 The successful bidder will be informed in writing of the intent to award or per an official order.
- 2.8 The bid has a validity period of 120 days from date of closure of the bid/tender.

3. SUBMISSION OF BIDS:

- 3.1 Bidders will be required to submit their bids/proposals via email or hand delivered as stipulated below:
- 3.1.1 Tenderers are required to submit a Completed Bid pack (this documents), including:
 - a) Duly completed and signed RFQ documents
 - b) B-BBEE certificate or Sworn Affidavit.
 - c) Proof of CSD registration report.
 - d) Submission of a minimum of three (3) most recent relevant reference letters on a client's letterhead with contact details.
- 3.2 Any bidder who fails to comply with any requirement of the bid may, at the discretion of the Bid Evaluation Committee, be regarded as non-compliant and as a result be rejected.

4. PAYMENTS:

- 4.1 The SANC undertakes to pay delivery validated invoices in full within thirty (30) days from the invoice date or upon agreed payment intervals as accepted in the contract. All invoices should be sent to the following email address: sancinvoices@sanc.co.za.
- **4.2** No invoices for outstanding deliverables or for any unproductive or duplicated time spent by the service provider will be validated for payment.
- 4.3 Invoices should be emailed or hand -delivered to SANC timeously.
- 4.4 The invoices should be original and must be accompanied by an inspection certificate and/or proof of delivery.

5. SUPPLY / DELIVERY VALIDATION:

5.1 The certificate and the related report of delivery/installation/ progress milestone/commissioning will be validated by a SANC representative prior to payment of final invoices.

6. VALUE ADDED TAX:

6.1 All contract prices are inclusive of 15% value added Tax (VAT), except in the case of a person that is not required to register for Value Added Tax. Companies not registered in terms of Value Added Tax, may not claim VAT on invoices.

7. PRICE AND PRICE QUALIFICATION:

- 7.1 Prices for this bid are firm.

- **9.2** The ownership and intellectual property rights of all designs, specifications, programming code and all other documentation provided by the SANC to the bidder/tenderer, both successful and unsuccessful, remain the property of the SANC.

10. SUPPLIER DUE DILIGENCE:

- **10.1** SANC may conduct due diligence on all shortlisted bidders/tenderers to identify their specific capabilities and/or financial stability.
- **10.2** The SANC may visit the premises of the bidders or those of their suppliers.

TERMS OF REFERENCE

REQUEST TO APPOINT A CONSULTANT TO CONDUCT THE NURSING PRACTICE/TASK ANALYSIS FOR LICENSURE EXAMINATION OVER EIGHTEEN (18) MONTHS PERIOD

1. PURPOSE

1.1 The purpose of this bid is to appoint a qualified and experienced consultant to conduct the nursing practice/task analysis in South Africa and ensure representativeness/ inclusiveness in terms of geographical areas, categories of nurses and areas of nursing practice for a period of eighteen (18) months.

2. BACKGROUND

- 2.1 The South African Nursing Council (SANC), is a statutory body which functions in terms of the Nursing Act, 2005 (Act No. 33 of 2005). It has a responsibility to establish, improve, monitor and control conditions, standards and quality of Nursing and Midwifery Education and Training within the ambit of any other applicable law. To fulfil this function, the SANC also accredits nursing education institutions and nursing programmes. SANC also approves clinical facilities used for experiential learning.
- 2.2 Education and training in South Africa is offered in Universities, Public Colleges and Private Nursing Education Institutions (NEIs).
- 2.3 Due to the changes in the education landscape in the country, the SANC is also in transition from the legacy nursing qualifications to the new nursing qualifications which are aligned to the Higher Education Qualifications Sub-framework (HEQSF).
- 2.4 SANC does not conduct the licensure examination as yet, however, SANC conducts certain examinations for private and public nursing colleges (for some programmes). Universities conduct their own examinations. Professional Registration into all categories of nursing is based on the academic certificates and transcripts submitted by the NEIs hence the SANC has resolved to adopt a licensure examination at this time of transformation of the nursing education and training.
- 2.5 Many countries including some developing countries in Africa have adopted the Licensure examination. In the process of benchmarking and extensive review of the literature, SANC saw the need to start with conducting the nursing practice/task analysis in order to ensure that the licensure examination is based on the context and is psychometrically and legally defensible. To achieve this, the Council approved that a consultant be commissioned to conduct the nursing practice/task analysis that will inform the blue print of the licensure examination.
- 2.6 The Nursing education and training system in the country produces qualifications through programmes of study from undergraduate to post graduate levels and these qualifications yield professional registrations as stipulated in the Nursing Act (Act No. 33 of 2005) section 31.
- 2.7 Table 1. below illustrate new and legacy nursing qualifications with the categories yielded by each qualification. This will assist the understanding of the two (new and old programmes) because currently there are no graduates/completed students from the new nursing programmes necessitating

that the nursing practice/task analysis project be conducted on graduates from the old programmes (including the recently completed students from the Higher Certificate in Nursing programme) to inform the licensure examination.
