1. CONTRACT PERIOD:

- 1.1** This is a three year contract for the appointment of a service provider for the FOR THE supply and installation of a security scanner for hand luggage and a walk-through metal detector at the South African Nursing Council.
- 1.2** SANC reserves the right to extend or cancel the contract, pending available funding and satisfaction with service delivery.

2. ACCEPTABLE BIDS/OFFERS:

- 2.1** The SANC reserves the right to cancel or withdraw the bid without prior notification.
- 2.2** SANC is not obliged to award the quotation to the lowest bidder.
- 2.3** The SANC may request interviews/presentations/pitching sessions with shortlisted bidders before the final selection is made.
- 2.4** The SANC will not be liable for any cost incurred by a service provider in the process of responding to this bid, including on-site presentations and the preparation of the proposal.
- 2.5** The SANC will not consider any late bids. All bids submitted after the stipulated closing date and time will not be considered and it will be sent back to the bidder unopened.
- 2.6** Any effort by the bidder to influence bid evaluation, bid comparisons or bid award decisions in any manner, may result in rejection of the bid concerned.
- 2.7** The successful bidder will be informed in writing of the intent to award or per an official order.
- 2.8** The bid has a validity period of 120 days from date of closure of the bid/tender.

4. PAYMENTS:

4.2 No invoices for outstanding deliverables or for any unproductive or duplicated time spent by the service provider will be validated for payment.

4.3 Invoices should be emailed or hand -delivered to the SANC timeously.

4.4 The invoices should be original and must be accompanied by an inspection certificate and/or proof of delivery.

5. SUPPLY / DELIVERY VALIDATION:

5.1 The certificate and the related report of delivery/installation/ progress milestone/commissioning will be validated by a SANC representative prior to payment of final invoices.

6. VALUE ADDED TAX:

6.1 All contract prices are inclusive of 15% value added Tax (VAT), except in the case of a person that is not required to register for Value Added Tax. Companies not registered in terms of Value Added Tax, may not claim VAT on invoices.

7. PRICE AND PRICE QUALIFICATION:

7.1 Prices for the first year are firm.

7.2 All prices shall be quoted in the South African currency (ZAR).

7.3 The bid prices shall be given in the units shown and will be awarded as a whole not per item.

7.4 Prices must be inclusive of delivery costs and all taxes.

7.5 Please note that the foreign exchange risk in case of imported goods and service is for the account of the bidder.

7.6 Please indicate the % escalation where required for the next two (2) years.

1. Purpose:

The South African Nursing Council (SANC) hereby invites suitably qualified and experienced service providers to submit proposals and quotations to supply and install a security scanner for hand luggage and a walk-through metal detector at the SANC's Cecilia Makiwane Building at **602 Pretorius Street, Arcadia, Pretoria 0083**.

2. Background and Discussion:

The SANC is committed to ensure a safe and conducive working environment by providing security systems to the building it occupies. In order to improve security at the SANC's premises, the Facilities Department would like to install a hand luggage security scanner and a walk-through metal detector at the entrance to the Cecilia Makiwane Building.

It is important for the SANC to ensure that its building is secured in accordance with the Access to Public Premises and Vehicle Act, Act 51 of 1995.

3. Scope of Work and Deliverables:

- a. One (1) fixed X-Ray inspection systems, equipped with the latest technology including a colour monitor which is switchable to Black and White, and the uninterruptible power source/supply.
- b. One (1) walk-through metal detector, with mains and battery supply unit, stabilizing plates for uneven floors, transport bag/container, infrared remote controller and waterproof protection.
- c. Support and Maintenance of the equipment for a period of three (3) years.
- d. The successful bidder is required to facilitate the issuing of a certificate by the Department of Health in terms of the Hazardous Substances Act (Act 15 of 1973) for the installation of X-ray machines.
- e. The successful bidder will be required to provide training and support to the users after installation of the system and issue competency certificates after training.
- f. The successful bidder should provide a manufacturer's warranty.
- g. Pricing must include operator's training, delivery, support, maintenance (for a period of three years), installation and commissioning.

4. Due Diligence and Site Visit:

The SANC may conduct due diligence with the shortlisted bidders before awarding the contract. The facilities of the shortlisted bidders will be expected to be accessible during office hours by the SANC's representative or their employees.

5. General Requirements:

- a) Registration with Private Security Industry Regulating Authority (PSIRA)
- b) The service provider shall ensure that its team has relevant expertise and provide diligent and necessary support to the SANC when required.
- c) The service provider will under no circumstance divulge, furnish, or disclose any sensitive information concerning the SANC or any other Stakeholders' activities to the public or news media. The SANC reserves the right to have confidentiality agreement signed with the successful service provider.
- d) The appointed service provider shall follow all statutory provisions and safety rules for carrying this work including but not limited to SANS and the OHS Act, no. 85 of 1993.
- e) The service provider must be an Accredited OEM Partner with the manufacturer of the equipment.

6. Site Briefing

There shall be a compulsory site briefing session on the 17 March 2021.

7. Evaluation Process:

In order to facilitate a fair and transparent selection process that allows equal opportunity to all bidders, the SANC has an SCM policy for the appointment of contractors or consultants that will be adhered to. Proposals will be evaluated in three steps (Administrative Compliance, Functionality, Price and B-BBEE).

The following qualifying criteria will be used:

a) **Step 1: Administrative Compliance:**

- i) Proof of Central Supplier Database (CSD) registration report.
- ii) Provide proof of compliance from Department of Labour (COIDA).
- iii) A minimum of three reference letters, on the client letterhead, where the same service has been rendered. The letters must not be older than five (5) years.
- iv) Registration with Private Security Industry Regulating Authority (PSIRA)
- v) OEM accreditation certificate from the manufacturer, the certificate must be on the manufacturer's letterhead.
- vi) Proof of financial stability or three years' audited or independently reviewed financial statements).

b) **Step 2: Functionality:**

Any proposed bid which does not meet a minimum threshold of 70% will not be considered further.

The following formula will be used to convert to the points scored against the weight:

c) Step 2: Price and B-BBEE:

Bids will be evaluated in terms of the **80/20 Preference Point System (80 points for price and 20 points for B-BBEE)**.

The following formula will be applied to calculate the points for price.

$$P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

P_s = Points scored for price of bid under consideration
 P_t = Rand value of bid under consideration
 P_{\min} = Rand value of lowest **acceptable** bid

The following formula will be used to calculate the points for B-BBEE:

Bids from non-compliant B-BBEE contributors will not be disqualified. Any B-BBEE qualifying contributor who does not submit a substantiating certificate will be allocated zero points but the bid will not be disqualified.

Points will be awarded to a tenderer for attaining their B-BBEE status level of contributor in accordance with the table below:
