1	BID SUBMISSION:
1. 1.1.	Bids must be delivered by the stipulated time to the correct address. Late bids will not be accepted for consideration.
1.2.	All bids must be submitted on the official forms provided— (not to be re-typed) or online
1.3.	This bid is subject to the Preferential Procurement Policy Framework Act 2000 and the Preferential Procurement Regulations, 2017, and, if applicable, any other legislation or Special Requirement of the Contract.
2.	TAX COMPLIANCE REQUIREMENTS
2.1	Bidders must ensure compliance with their tax obligations.
2.2	Application for tax compliance status (tcs) pin may be made via e-filing through the sars website www.sars.gov.za.
2.3	In bids where consortia / joint ventures / sub-contractors are involved, each party must submit a separate tcs certificate / pin / csd number.

SPECIAL REQUIREMENT OF THE BID:

1. CONTRACT PERIOD:

1.1 This is a five (5) years contract for the appointment of a panel of recruitment service providers to assist the South African Nursing Council with recruitment services for a period of five (5) years.

2. ACCEPTABLE BIDS/OFFERS:

- **2.1** The SANC reserves the right to cancel or withdraw the bid without prior notification.
- **2.2** SANC is not obliged to award the bid to the lowest bidder.
- 2.3 The SANC may request interviews/presentations/pitching sessions with shortlisted bidders before the final selection is made.
- 2.4 The SANC will not be liable for any cost incurred by a service provider in the process of responding to this bid, including on-site presentations and the preparation of the proposal.
- 2.5 The SANC will not consider any late bids. All bids submitted after the stipulated closing date and time will not be considered and it will be sent back to the bidder unopened.
- **2.6** Any effort by the bidder to influence bid evaluation, bid comparisons or bid award decisions in any manner, may result in rejection of the bid concerned.
- **2.7** The successful bidder will be informed in writing of the intent to award or per an official order.
- **2.8** The bid has a validity period of 120 days from date of closure of the bid/tender.
- 2.9 No bid may be awarded to a person who has failed to submit proof of his/her tax compliance status (tax clearance certificate and personal identification number issued by SARS) or any proof certifying that the taxes of that person is in order or that suitable arrangements have been made with SARS,
- **2.10** Where it is discovered that an advantaged company used a disadvantaged person, as a "front" to acquire a Bid, such company will be disqualified and the Bid shall be withdrawn.

3. SUBMISSION OF BIDS:

- **3.1** Bidders will be required to submit their bids/proposals through hand delivered as stipulated below:
- **3.1.1** Tenderers are required to submit a Completed Bid pack (this documents), including:
 - a) Duly completed and signed RFP documents
 - b) B-BBEE certificate or Sworn Affidavit.
 - c) Proof of CSD registration report.
- 3.2 Any bidder who fails to comply with any requirement of the bid may, at the discretion of the Bid Evaluation Committee, be regarded as non-compliant and as a result be rejected.

4. PAYMENTS:

- 4.1 The SANC undertakes to pay delivery validated invoices in full within thirty (30) days from the invoice date or upon agreed payment intervals as accepted in the contract. All invoices should be sent to the following email address: sancinvoices@sanc.co.za.
- **4.2** No invoices for outstanding deliverables or for any unproductive or duplicated time spent by the service provider will be validated for payment.
- **4.3** Invoices should be emailed or hand-delivered to SANC timeously.
- **4.4** The invoices should be original and must be accompanied by an inspection certificate and/or proof of delivery.

5. SUPPLY / DELIVERY VALIDATION:

5.1 The certificate and the related report of delivery/installation/ progress milestone/commissioning will be validated by a SANC representative prior to payment of final invoices.

6. VALUE ADDED TAX:

6.1 All contract prices are inclusive of 15% value added Tax (VAT), except in the case of a person that is not required to register for Value Added Tax. Companies not registered in terms of Value Added Tax, may not claim VAT on invoices.

7. PRICE AND PRICE QUALIFICATION:

- **7.1** Prices for the first year are firm.
- **7.2** All prices shall be quoted in the South African currency (ZAR).
- 7.3 The bid prices shall be given in the units shown and will be awarded as a whole not per item.
- **7.4** Prices must be inclusive of delivery costs and all taxes.
- **7.5** Please note that the foreign exchange risk in case of imported goods and service is for the account of the bidder.
- **7.6** No changes or extensions or additional ad hoc costs are accepted once the contract has been awarded and/or signed.

8. COMMUNICATION:

- **8.1** Communication will only be restricted to Supply Chain Management Officials.
- **8.2** The South African Nursing Council may request clarification in writing regarding the information provided by bidders. Bidders are to supply the required information within the specified period. Failing to do so may invalidate your bid.

9. INTELLECTUAL PROPERTY:

- **9.1** All the information contained in this document is intended solely for the purpose of assisting bidders to prepare their bids. Any use of the information contained herein for another purpose than those stated in this document is prohibited.
- **9.2** The ownership and intellectual property rights of all designs, specifications, programming code and all other documentation provided by the SANC to the bidder/tenderer, both successful and unsuccessful, remain the property of the SANC.

10. SUPPLIER DUE DILIGENCE:

- **10.1** SANC will conduct due diligence on all shortlisted bidders/tenderers to identify their specific capabilities and/or financial stability.
- **10.2** The SANC may visit the premises of the bidders or those of their suppliers.
- 10.3 Some of the key elements that should be documented and included during the comprehensive supplier analysis/due diligence include: the current workload of the supplier, cost structure of the tender/bid, the financial status of the bidder/tenderer, the previous customer satisfaction levels, the support capabilities, their relative strength, weaknesses and core capabilities, how SANC fits into the tenderers/bidders business and how the tenderer/bidder is viewed by the public, etc.
- **10.4** Bidders may be required to provide names of traceable references who may also be visited to confirm their testimonials.

11. DISPUTES

11.1 The relevant bidder agrees that should any dispute arise from the contract, the matter shall be submitted to the relevant Bid Adjudication Committee for a ruling and such ruling shall be final.

TERMS OF REFERENCE

APPOINTMENT OF A PANEL OF RECRUITMENT SERVICE PROVIDERS TO ASSIST THE SOUTH AFRICAN NURSING COUNCIL WITH RECRUITMENT SERVICES FOR A PERIOD OF FIVE (5) YEARS

1. PURPOSE

- 1.1 The South African Nursing Council (SANC) intends to appoint a maximum of three (3) service providers to render a recruitment service as follows for a period of five (5) years.
 - 1.1.1. Advertising of vacant permanent and contract posts;
 - 1.1.2. Executive Search / Headhunting for selection posts; and
 - 1.1.3. Response Handling Management Services.
- 1.2 The advertising of posts will include relevant local and national newspapers. The job advertisement will include only the name of the vacant position and methods of submitting applications. Applicants will be directed to the SANC website for details of the positions.

2. OBJECTIVE

2.1 The specific objective of this project is to assist the SANC to expedite the filling of critical funded vacant positions in order to have full capacity to deliver on the mandate of the organisation.

3. BACKGROUND:

- 3.1 The SANC is a body entrusted to set and maintain standards of nursing education and practice in the Republic of South Africa. It is an autonomous, financially independent, statutory body initially established by the Nursing Act, 1944 (Act No. 45 of 1944) and currently operating under the Nursing Act, 2005 (Act No. 33 of 2005).
- 3.2 The SANC intends to contract with three (3) suitably qualified service providers that will assist to advertise permanent and contract positions, manage the response handling services and conduct executive search/headhunting (for selected positions) for a period of five (5) years. This will be provided at the SANC offices located in Arcadia, Pretoria, Gauteng.
- 3.3 The SANC is in the process to implement the reviewed organizational structure and contracting with three (3) service providers is critical to expedite the filling of critical funded vacant positions within the SANC.
- 3.4 The appointment of the service providers will improve the turnaround time to fill critical positions.
- 3.5 Due to the recruitment volume, SANC seeks to appoint a maximum of three (3) service providers in a panel of recruitment agencies who will be expected to advertise positions and effectively and efficiently handle all the applications that are received i.e. sorting, capturing, screening and arranging the applications into three different lists ie. (1) Meets and exceeds the added advantage advertised requirements, (2) partially meets the added advantage requirements and (3) does not meet the compulsory minimum advertised requirements.

4. SCOPE OF SERVICE

4.1 The scope of work covers the following:

- a) advertising vacancies accurately as submitted by the SANC, in both local and national newspapers;
- b) providing a response handling service for the SANC after applications are received, by sorting the same applications received, into the following categories:
 - 1) Total number of applications received by the closing date;
 - 2) Total number of applications received after the closing date, if any;
 - 3) High level summary of employment equity breakdown of applications received by the closing date;
 - 4) Applications received by the closing date sorted as follows:
 - **List A** Applicants do not meet the compulsory minimum advertised requirements and are eliminated;
 - List B Applicants meet the compulsory minimum advertised requirements;
 - List C Applicants partially meet the added advantage advertised requirements;
 - List D Applicants meet the added advantage advertised requirements; and
 - List E Applicants exceed the added advantage advertised requirements.
- c) providing the report to the SANC within the agreed turnaround time (both electronic and manual).
- d) conducting the executive search / headhunting when required by the employer for specific posts.

5. ROLES AND RESPONSIBILITIES

- 5.1. SANC will provide the approved advertisement for placement in the local and national member.
- 5.2 Applications for all advertised positions will be received at the official SANC email address by the SANC. The appointed service provider that is managing the recruitment process, will be given secure access to the SANC email inbox, to capture the cv's related to the specific advertisement and screen the applications as required.

6. DURATION OF THE SERVICES REQUIRED

6.1 The Service Level Agreement will be for a period of five (5) years subject to annual review based on performance by the service provider.

7. REPORT REQUIREMENTS

- 7.1 The service provider will be required to provide a report of each position captured and prescreened.
- 7.2. The report format should be agreed upon between the service provider and the SANC.
- 7.3. Invoices should be accompanied by the required reports for processing of payments.
- 7.4 Service provider will be required to be available for face to face, Ms Teams or telephonic consultations.

8. CONFIDENTIALITY OF INFORMATION

8.1. Information/data to be provided to the service provider will remain the property of SANC and the service provider should treat all the data with the required confidentiality and also return all the data to SANC after the completion of the project.

9. DUE DELIGENCE

- 9.1. Due diligence that will be conducted by the SANC will include amongst others:
- 9.1.1 a thorough analysis of the proposal that is received by the service provider including background checks on each member of the assigned team from the service provider, on-site visits and financial feasibility checks.

11. PROPOSAL

11.1. The service provider will be requested to submit a quotation for the work to be undertaken in this project in this project inclusive of all services to be rended, for a period of five (5) years.

12. EVALUATION PROCESS

12.1. Bids will be evaluated in three steps (Mandatory and Administrative Compliance, Functionality, Price and B-BBEEE).
