Background

- In terms of Section 4 (1) (c) of the Nursing Act, 2005 (Act No. 33 of 2005), under the functions of the Council, the Council must:
 - (c) conduct examinations, and appoint examiners and moderators, and grant diplomas and certificates in respect of such examinations
- 

Background Cont.

- (n) monitor the assessment by education and training providers, including recognition of prior learning (RPL), register constituent assessors and moderators and grant diplomas and certificates in accordance with the requirements of the Act and any other law
-

Registration: Completion of Training for R.425 Learners: Background

- The SANC is experiencing challenges with completion of Community Service for R.425 Learners
 - Some Provinces delay to submit completion of Community Service reports to SANC
 - This causes administrative challenges at SANC

Background cont.

- This leads to some Practitioners working without Registration Certificates as Registered Nurses

Completion of Training and registration as a Community Service Practitioners cont.

- In order to fast-track the registration process, the following must be done:
- Ensure that the correct payment is done as per SANC Circular 08/ 2022 on Fees and Fines
- Correct code must be used when making a bank deposit. Please insert the SANC Reference number, followed by the code REGFPRA, e.g., (000000000REGPRA)

Completion of Training and registration as a Community Service Practitioners cont.

- Forms must be correctly completed
 - Upon completion of Community Service, the completion report must be submitted to SANC by the Provincial Coordinator of each province
 - No individual notice of completion will be accepted.

Completion of Training and registration as a Community Service Practitioners cont.

- No emailed documents will be accepted because all documents must via Registry for document control
 - Completion of training records or completion of Community Service must be submitted to SANC after thirty(30)days of completion of training
