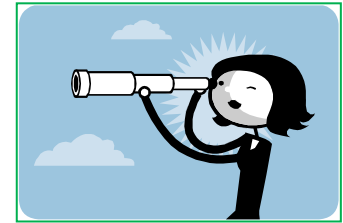

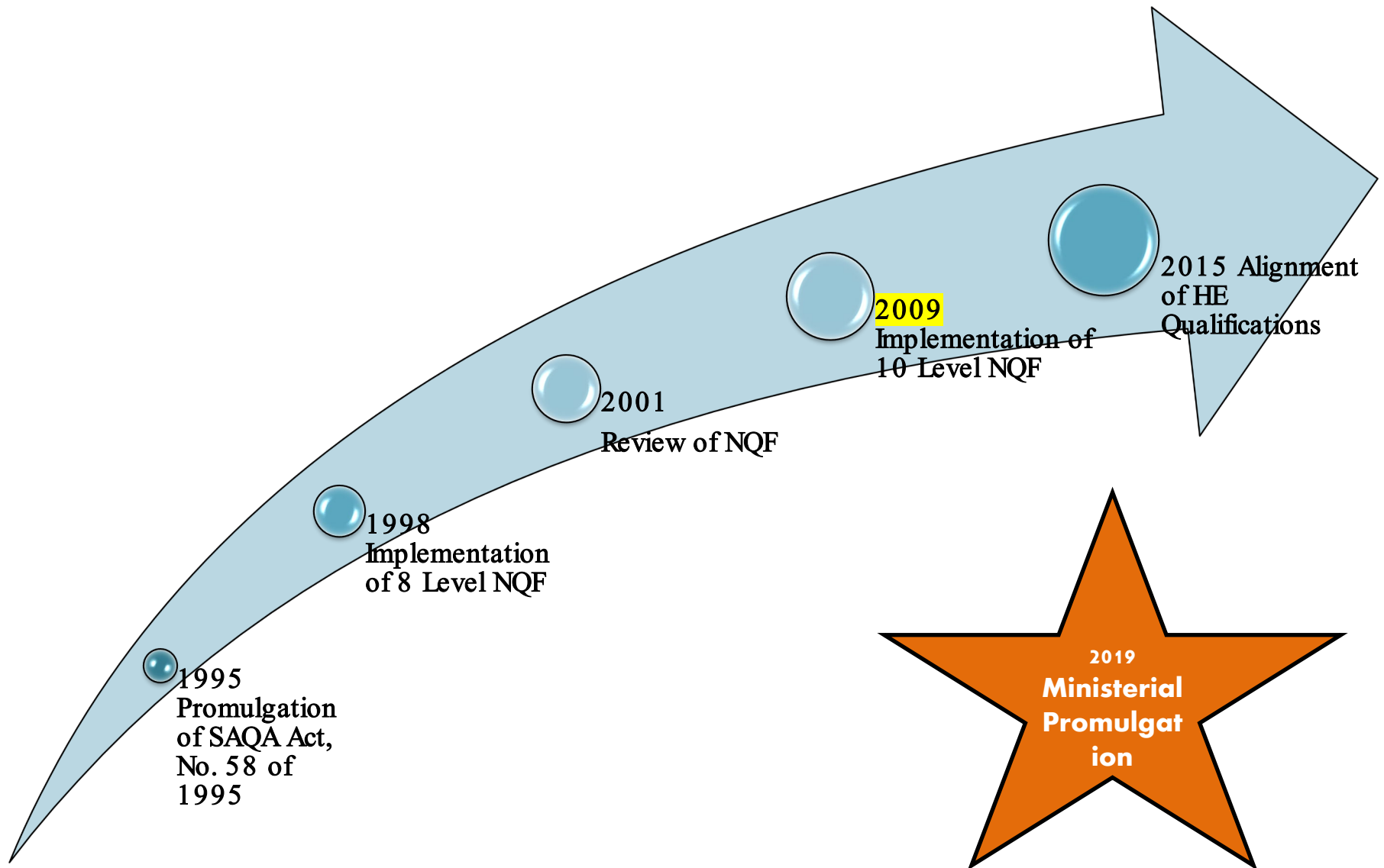

Background

- Transformation in HE in SA spearheaded by the Minister of Higher Education and Training, necessitated transformation in all learning fields, including Nursing Education.
- The introduction of the HEQSF, as part of SA NQF, created a need to align the Nursing qualifications with the HEQSF.
- HEQSF provides the basis for integrating all HE qualifications into the NQF, and also provides a basis for standards development and quality assurance.
- In 2016, the Minister of HET, in line with the provision of the Higher Education Act, 1997 (Act 101 of 1997), declared through a notice published in a gazette, that the last enrolment date for the first-time entering students into academic programmes that are not HEQSF-aligned was 31 December 2019.
- This meant that the legacy programmes, including legacy nursing education programmes would no longer be offered after the stipulated date except to complete the pipeline students.

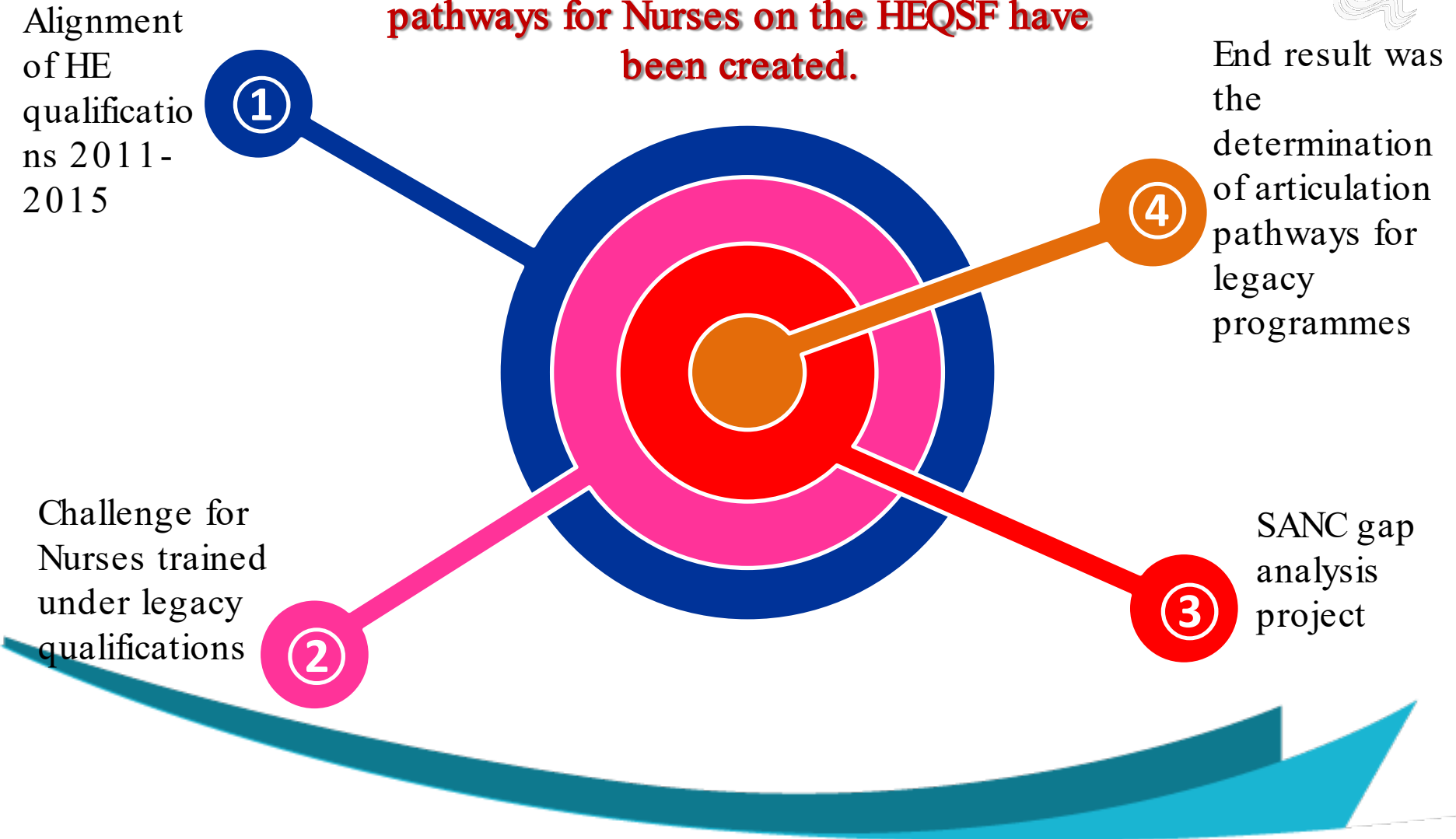
Summary: NQF Act, Act 67 of 2008

- NQF is a means for transforming education and training in SA and was designed to:
 - Create a single, integrated, national education and training framework for the whole nation.
 - Make it easier for learners to enter the education and training system and to move and progress within it.
- In line with international trends to ensure quality, and comparable standards of needs-driven and coherent training in a country, a national, 8-level qualifications framework was developed in 2000.
- This meant that all qualifications offered in the country had to fit into one of these levels and had to comply with the level requirements. Its implementation was overseen by the SAQA.

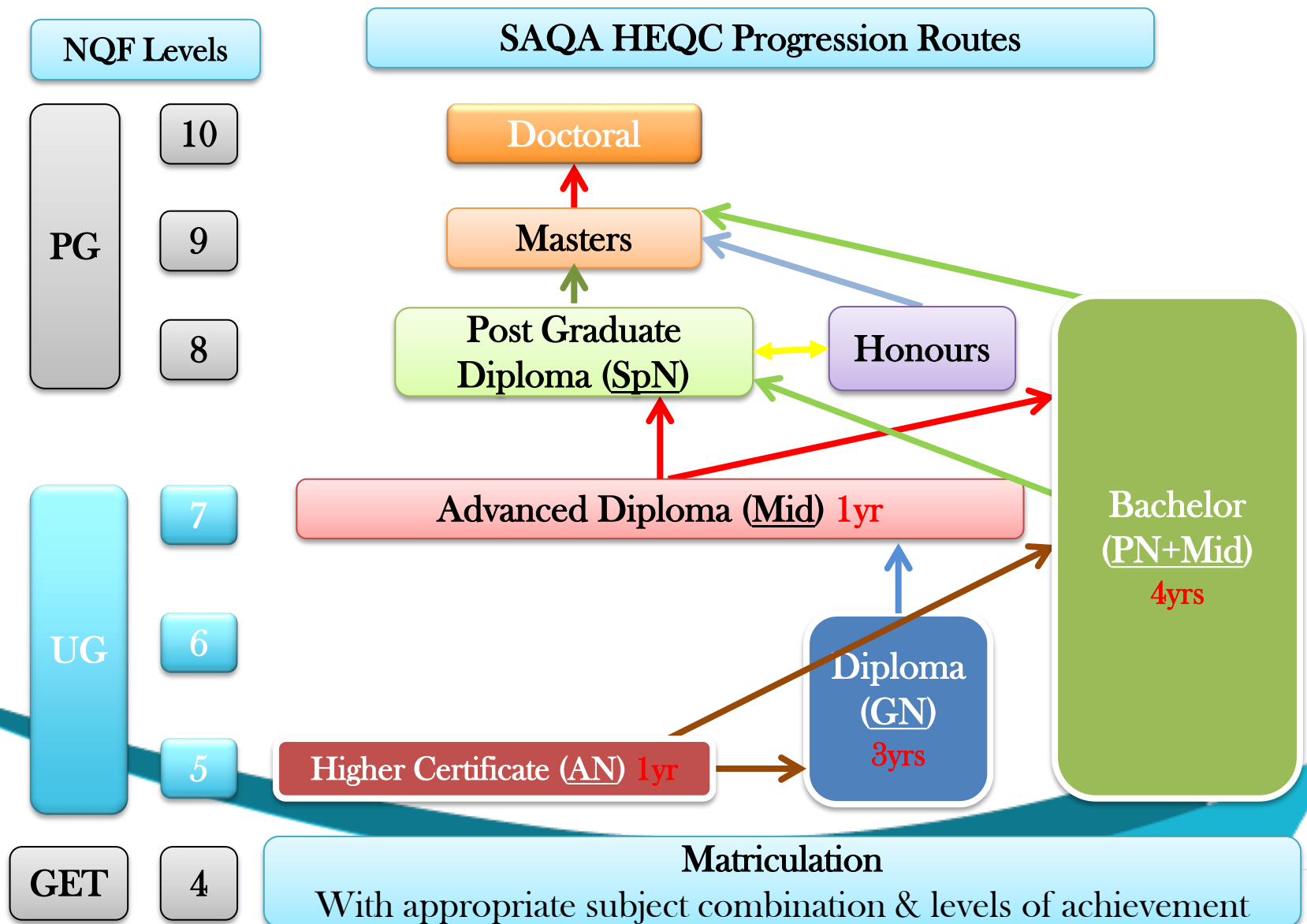

Articulation

- Articulation entails the mechanisms that enable student mobility within and among the institutions of learning.
- The articulation process formulate possibilities of connection between qualifications to allow for vertical, lateral and diagonal movement of students through formal education and training system and its linkages with the world of work.
- Types of articulations:
 - **Vertical articulation** is articulation across NQF levels within an NQF Sub-framework
 - **Horizontal articulation** is articulation within and between NQF Sub-frameworks, on the same NQF level
 - **Diagonal articulation** is articulation across NQF levels and across NQF Sub-frameworks

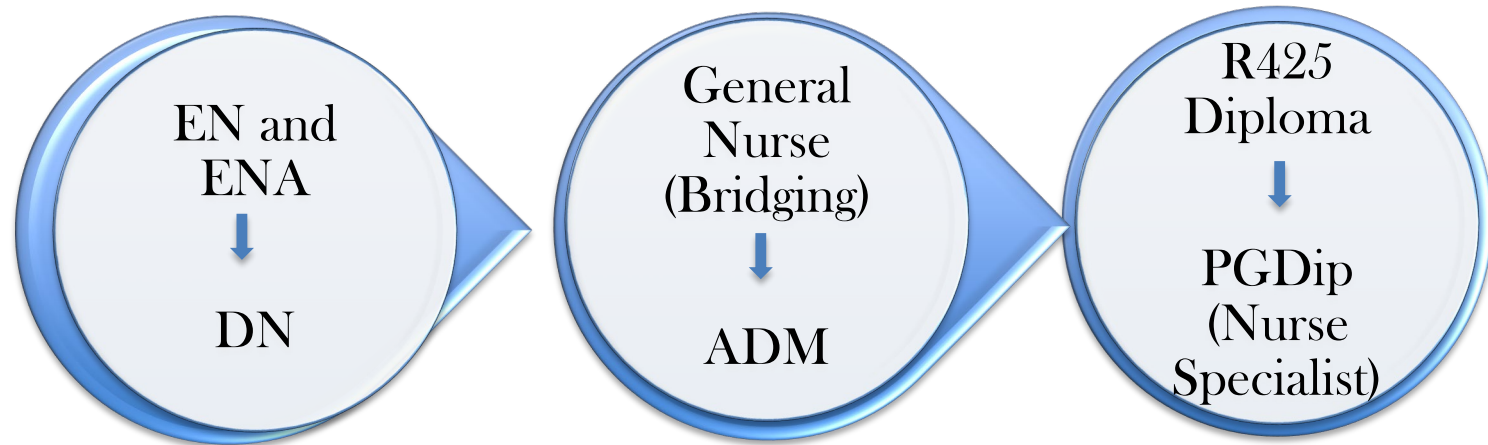

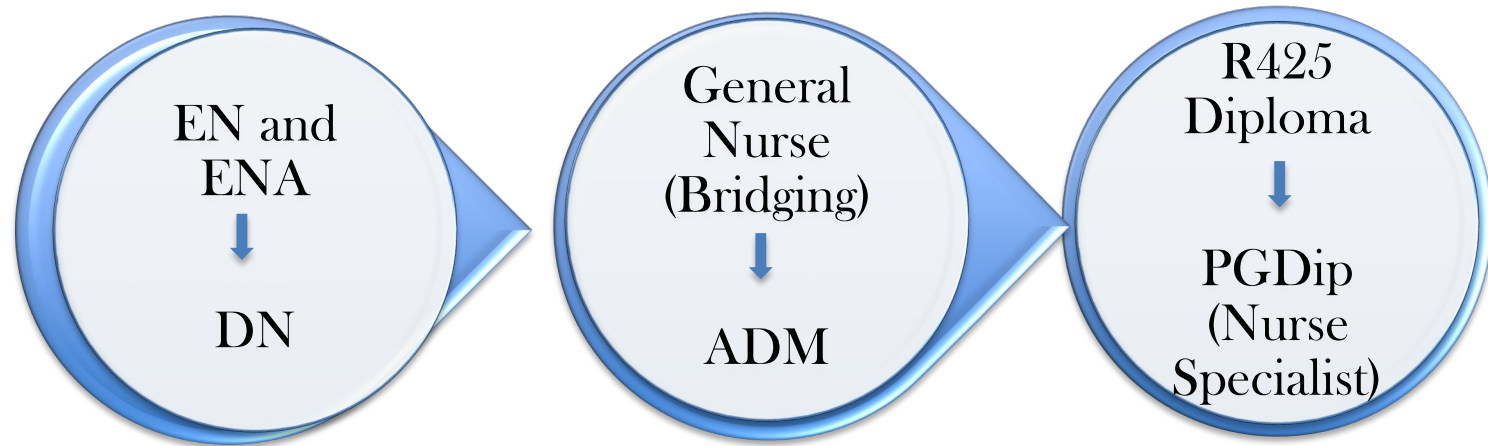
