PILOT FINDINGS

- There are best practices in nursing practice management in the midst of challenges.
- There are health establishments and units led by managers without health service management qualifications.
- There are Speciality heath establishment and units led by managers without the relevant speciality and no HSM qualifications.
- Some Policies and SOPs not adhered to.

....PILOT FINDINGS

- Limited evidence for communication of acts, regulations, policies to staff.
- Required SOPs signed a day or two before the inspection.
- Limited evidence for review of nursing care by supervisors and shift leaders.
- Limited evidence for delegation and completion of task in nursing units.
- Nurses code of ethics mostly not available.
