- In depth knowledge of Nursing regulations and guidelines
- Specialisation in one of the following disciplines in Midwifery or Psychiatric or primary health care and critical care

KEY PERFORMANCE AREAS

- Assess and analyse using technical nursing clinical knowledge, the appeals filed by the Respondent's in relation to the charges, Professional Conduct Committee verdict and sanction imposed.
- Apply knowledge of nursing regulations and polices to the facts of the appeal in determination of the verdict of the PCC.
- Contribute to the determination of the fairness of the sanction in relation to the conduct and impact of the appellant in relation to the PCC verdict and sanction.
- Contribute to the drafting of the appeal judgement/ruling.
